# Resident Charged With Road Rage

Last Wednesday morning a 38-yearold female Plainfield resident drove into the South Plainfield Police Department parking lot and reported that a motorist had just pointed a gun at her.

She said that she had apparently not let the motorist merge as they both proceeded through a traffic light. The motorist reportedly followed her to the intersection of Maple Ave. and Plainfield Ave., where both were stopped at a traffic light. The motorist reportedly exited his vehicle yelling at her, then pointed a handgun at her. She described the suspect as being a white male operating a light blue full size pick-up truck.

The next morning, patrol and detective units established a surveillance of a vehicle matching the description given by the victim. As a result, David A. Riccadonna, 40, was stopped and detained. The victim identified him as the suspect. He was transported to headquarters and charged with aggravated assault, possession of a weapon for an unlawful purpose and unlawful possession of a weapon. A handgun was recovered at his residence.

Bail has been set at \$10,000 for Riccadonna, who is a resident of South Plainfield.

# Jeff Temple Arrives at Winter Olympic Games

"Greetings from the Olympics!" read the email from South Plainfield resident Jeff Temple. Jeff, a Metuchen Police office is currently working as a law enforcement volunteer at the 2002 Winter Olympics in Utah.

Jeff arrived in Salt Lake early for several days of training before the games began. He worked from 7 a.m. to 4:30 p.m. every day, with just four days off over the three-week period. The hours are long and cold, often with temperatures in the single digits, but Jeff is enjoying the experience of alifetime.

In his email Jeff said, "There has been so much going on here it is unbelievable. I have been assigned to steady days, but things seem to change on almost an hourly basis around here. The residents of Utah are very friendly and all of the people associated with the games are so appreciative of us."

Jeff's assignment is security detail at the Olympic Family Hotel in Salt Lake City, which houses all of the International Olympic Committee Members, dignitaries, royalty and heads of state. His duties vary from foot patrol to conducting metal detector entry point and done vehicle searches. He works with police officers from all over the country. Jeff noted the training was thorough and covered all aspects of public safety. Security is tight, with many security personnel on hand, as well as an obvious military presence. Blackhawk helicopters are seen on a daily basis over the city. Jeff said the continuing joke amongst the officers is with all the focus on terrorism, officials keep stressing that officers should not use non-sponsored products while on assignment or while in uniform. Jeff described sights not visible to TV viewers—rows of riflemen, who line the stadium top and helicopters constantly hovering with search lights, panning the sky for

would-be trouble-makers.

Jeff continued, "Everyone here is friendly and psyched up for the Olympic games!" On opening day he watched the Olympic Torch pass Westminster College where some of the officers are housed. Hundreds of spectators lined the streets waiting for a glimpse of the torch. Corporate sponsors were on hand passing out small flags and soft drinks while the crowd awaited the arrival of the torch and to see it passed to the president of the college.

Off duty on Sunday, Jeff attended the opening ceremony as a spectator. Jeff admitted, "A terrorist attack was in back of our minds, but the show was spectacular and kept us from thinking about it. There is a tremendous feeling of pride and patriotism here. "Meanwhile, Jeff continues to enjoy the Olympic experience. He has tickets to a number of events including the Woman's Finals Freestyle Ice Skating. He has done some sight seeing and hopes to see more of the Salt Lake City area before he leaves Utah.

He has met Steve Young, former NFL quarterback of the San Francisco 49ers and he saw former Secretary of State Madeline Albright. He has captured moments of this dream on film, the torch enroute being passed along the way and athletes entering the stadium.

Ironically it is the threat of terrorism that makes his job so much more vital. Whatever the reason, Metuchen Police officer Jeff Temple was grateful for the opportunity to realize his dream and to attend the Olympic Games. While the threat of terrorism has not diminished the excitement, it is a constant at the games, just as it has been every day since Sept. 11 in every American's life.

# Thomas Named Chairman of PARSA

Bill Thomas was elected Chairman of the Plainfield Area Regional Sewerage Authority (PARSA) at PARSA's meeting held on Feb. 7.

PARSA is a regional sewerage authority formed in 1995 representing South Plainfield, Dunellen, Fanwood, Green Brook, Plainfield, North Plainfield, Scotch Plains and Watchung. Each of these towns appoints one member to the authority.

Thomas was first appointed by the Mayor and Borough Council as their representative in 1995. PARSA provides for the conveyance of sewerage from member towns to the sewerage treatment facilities of the Middlese County Utilities Authority. PARSA also assists its members towns in sewer maintenance tasks such as cleaning lines, video taping problem areas with specialized camera equipment and diagnosing infiltration problems.

PARSA's facilities are located on Clay Ave. in Middlesex. Thomas is a senior partner in the Princeton office of the law firm of Hale and Dorr LLP, where he practices corporate and securities law. Thomas, who is also Chairman of the Borough's Zoning Board of Adjustment, lives on Lowden Ave. with his wife, Kathy, and their daughters, Kelly and Kara.

point is we all have obstacles that stand in our way of good health.


